*February 21- [HHS Issues Strategy to Improve Care for Patients by Reducing Clinician Burdens](#).

As part of the ongoing efforts to strengthen the relationship between patients and their doctors, the U.S. Department of Health and Human Services (HHS) today issued the *Strategy on Reducing Regulatory and Administrative Burden Relating to the Use of Health IT and EHRs*.

Going back to my time in Indiana designing health care plans, I have always valued the knowledge and expertise that agents and brokers bring to the table, because they have front line experience. *February 26- [HHS Awards \\$117 Million to End the HIV Epidemic in the United States](#). Today, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), awarded approximately \$117 million to expand access to HIV care, treatment, medication, and prevention services. This investment is a critical component of the Administration's [Ending the HIV Epidemic: A Plan for America \(EHE\)](#) initiative, which aims to reduce the number of new HIV infections in the United States by 90 percent by 2030.

*February 27- [HHS Appoints Former Kansas Governor Jeff Colyer Chair of the National Advisory Committee on Rural Health and Human Services](#). Today, HHS Secretary Alex Azar announced the appointment of former Kansas Governor Jeff Colyer, to serve as Chair of the National Advisory Committee on Rural Health and Human Services (NACRHHS).

*February 27- [CMS Selects Applicants for Participation in Innovative Payment Model with New Emergency Treatment and Transport Options](#). Today, the Centers for Medicare & Medicaid Services (CMS) is announcing the selection of 205 applicants to participate in the Emergency Triage, Treat, and Transport (ET3) Model, a payment model that aims to allow beneficiaries to access the most appropriate emergency services at the right time and place. The voluntary, five-year payment model will provide greater flexibility to ambulance care teams to address emergency health care needs of Medicare Fee-for-Service beneficiaries following a 911 call.
