*June 12- [OCR Issues Guidance on How Health Care Providers Can Contact Former COVID-19 Patients About Blood and Plasma Donation Opportunities](#). Today, the Office for Civil Rights (OCR) at the U.S Department of Health and Human Services (HHS) issued guidance on how the Health Insurance Portability and Accountability Act of 1996 (HIPAA) Privacy Rule permits covered health care providers to contact their patients who have recovered from COVID-19 to inform them about how they can donate their blood and plasma containing antibodies to help other patients with COVID-19.

*June 12- [HHS Finalizes Rule on Section 1557 Protecting Civil Rights in Healthcare, Restoring the Rule of Law, and Relieving Americans of Billions in Excessive Costs](#). Today, the U.S. Department of Health and Human Services (HHS) finalized a rule under Section 1557 of the Affordable Care Act (ACA) that maintains vigorous enforcement of federal civil rights laws on the basis of race, color, national origin, disability, age, and sex, and restores the rule of law by revising certain provisions that go beyond the plain meaning of the law as enacted by Congress. The final rule will also relieve the American people of approximately \$2.9 billion in undue and ineffective regulatory burdens over five years.

*June 14- [Secretary Azar statement on World Blood Donor Day](#). Sunday, June 14, marks World Blood Donor Day, which highlights the importance of blood donation while thanking the millions of people around the world who give blood. HHS Secretary Alex Azar released the following statement in commemoration of the day.

*June 15- [Albertsons Companies and Walmart Donate Their Dispensing Services to HHS to Support the Ending the HIV Epidemic Initiative](#). The [U.S. Department of Health & Human Services \(HHS\)](#) will further expand access to pre-exposure prophylaxis (PrEP) HIV prevention medications by adding donated dispensing services from [Albertsons](#)  Companies and [Walmart](#)  to the the [Ready, Set, PrEP](#) program beginning no later than July 30, 2020. The program allows uninsured patients to fill their prescriptions at no cost.

*June 18- [HHS Awards \\$107.2 Million to Grow and Train the Health Workforce](#). Today, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), is announcing awards totaling \$107.2 million to 310 recipients to increase the health workforce in rural and underserved communities. Recipients across 45 states and U.S. territories received funding to improve the quality, distribution and diversity of health professionals serving across the country.
